

Florida Statute 768.0706 Compliance Checklist

Multifamily Residential Property Security Requirements (5+ Units)



SECURITY CAMERA SYSTEM

Cameras installed at ALL entry/exit points Video recording capability for offender identification 30-day minimum retrievable footage storage System operational 24/7 with backup procedures



Parking Areas:

Minimum 1.8 foot-candles per sq ft (measured 18" above surface)

Dusk-to-dawn illumination (photocell or electronic controls)

Common Areas - Dusk-to-Dawn Lighting: All walkways and pedestrian paths Laundry rooms (interior and exterior access) All common areas (mailbox, recreation, trash areas) Individual unit porches/patios

1-inch deadbolts on all dwelling unit doors Locking devices on all windows Locks on all exterior sliding doors Locks on non-community access doors

Peepholes/door viewers on units without door/ adjacent windows

Locked gates with key or fob access on pool fence perimeter

Access control system with tracking procedures

CPTED ASSESSMENT (Required Since January 1, 2025)

Assessment completed by a qualified professional: Law enforcement agency, OR FL Crime Prevention Through Environmental Design Practitioner

Assessment no more than 3 years old

Written report with recommendations received Implementation plan created for all recommendations Substantial compliance maintained with assessment

S EMPLOYEE TRAINING PROGRAM

All Current Employees (Required Since January 1, 2025):

Crime deterrence and safety training completed

Training covers security principles, devices, measures, and standards

Training documentation maintained

New Employees (Ongoing Requirement):

Training within 60 days of hire date established

Standardized training program implemented

Ongoing Requirements:

Training curriculum reviewed every 3 years Updates implemented as necessary

COMPLIANCE DOCUMENTATION

Critical: Burden of proof is on the property owner to demonstrate "substantial implementation"

Photo documentation of all security installations Vendor contracts and compliance certificates CPTED assessment report and implementation records Employee training records and completion certificates Regular maintenance and inspection logs Compliance verification file prepared for legal defense

Key Deadline & Reminders

- Required since January 1, 2025: CPTED assessment must be completed
- Required since January 1, 2025: All current employees must have completed training
- Ongoing: New employees trained within 60 days of hire
- Every 3 Years: Training curriculum review and CPTED assessment renewal

Required since January 1, 2025: CPTED assessment must be completed

- Property must have 5+ dwelling units on a single parcel
- ALL security measures must be "substantially implemented"
- Partial compliance does NOT provide liability protection
- Applies only to criminal acts by third parties (not employees/agents)

LEGAL CONSULTATION REQUIRED

This statute provides a presumption against liability, not absolute immunity. Property owners should consult with qualified attorneys familiar with Florida premises liability law to understand full legal implications and ensure complete compliance.
